Sub: Amendment in regulation 41(a) of the regulation of the NCERT

The amendment in Regulation 41(a) of the Regulations of NCERT has been approved by the Govt. of India, MHRD vide letter No.F.1-19/2007-Sch. 4 dated 21.08.2017 and the Executive Committee of the NCERT in its meeting held on 25.04.2018.

Accordingly the following amendment in the regulations 41(a) of the regulations of the Council is hereby notified for the information of all the concerned.

Regulation 41 (a)

Existing	Amended
Every member of the academic staff confirmed in the service of the Council shall continue in such service until he/she attains the age of 60 years.	Every member of the academic staff confirmed in the service of the Council shall continue in such service until he/she attains the age of 65 years.

administration or academic duties or both to the academic and administrative staff. With the prior consent of the employee, a member of the academic staff may be permanently transferred to the administrative wing and vice-versa.

- 37(a) The Executive Committee shall, by resolution, lay down eligibility conditions for the different categories of posts.
- 38. The scales of pay, allowances and retirement benefits for the employees of the Council shall not be in excess of those prescribed by the Government for similar personnel from time to time.
- 39. Certain categories of employees, particularly those having medical and engineering qualifications, may have to give an undertaking to serve in the Defence Services in accordance with the orders issued from time to time by the Government of India.
- 40. There shall be a reservation of posts in the Establishment of the Council in accordance with the orders of the Government of India for members of Scheduled Castes and Tribes. There shall also be relaxation of age and other restrictions in favour of members of communities classified as Scheduled Castes and Tribes in accordance with the orders issued by the Government of India from time to time.
- 41. (a) Every member of the academic staff confirmed in the service of the Council shall continue in such service until he/she attains the age of 65 years.
- (b) The age of superannuation of the confirmed employees of the Council, other than the academic staff members mentioned in Regulations 41 (a) shall be the same as obtaining in the Government of India. However, the age of retirement of such staff appointed in the Council
