





1. Condemned unpriced publication (books/papers) will be sold out on "**As is where is basis**" to the highest bidder.
2. The sale/bid value shall be deposited by the highest bidder on the same day in cash.
3. The interested bidders will have to deposit the **DD/BC only** to the tune of Rs.10,000/- as Security/EMD in favour of Secretary, NCERT & refundable to the unsuccessful bidder.
4. The condemned unpriced publication (books/papers) can be inspected on any working day between 10.30 a.m. to 4.30 p.m. in the premises of **Central Warehousing Corporation Godown, Sector-68, Noida, U.P.**
5. The possession of condemned unpriced publication (books/papers) will be given to the highest bidders on payment of sale/bid value.
6. The highest bidder/purchaser will have to remove the condemned unpriced publication (books/papers) within three days at their own cost. Thereafter, an amount of Rs.2000/- per day will be charged as ground rent.
7. In case, if the highest bidder does not lift the condemned unpriced publication (books/papers) on the same day or even within the time given in Sr. No. 6, the bid security/EMD of Rs.10,000/- deposited by him shall be forfeited and liable for taking action against him i.e for re-sale of the condemned material at the risk and cost of the depositor.
